

Enroll now to save your business on energy costs

The CleanPowerSF Peak Day Pricing Program offers large commercial accounts an opportunity to earn an incentive while helping reduce carbon emissions. CleanPowerSF will call up to twelve Event Days starting July 1. CleanPowerSF's Peak Day Pricing Program is risk-free.

PARTICIPATION: Peak Day Pricing is open to CleanPowerSF customers on E-19, B-19, E-20, and B-20 rate schedules. Program participants may be on Green or SuperGreen service. Program participants may not be netenergy metered (NEM), standby accounts, or enrolled in other demand response programs offered by PG&E or other demand response program providers, with the exception of PG&E's Emergency Load Reduction Program. They also must have been an enrolled CleanPowerSF customer as of July 27, 2023 (including those rejoining CleanPowerSF service who previously opted out). Participation in the program is voluntary. CleanPowerSF reserves the right to limit total participation in the program to 50 service agreements.

HOW IT WORKS: Enrolled customers will continue to be charged their standard CleanPowerSF electric rate with no difference in monthly billing. CleanPowerSF determines the customer's final incentive with a one-time calculation after the program season.

When the program season ends, CleanPowerSF calculates PDP incentives based on the customer's electricity use between 4 and 9 p.m. on each PDP Event Day relative to the account's expected electricity use if a PDP Event Day had not been called.

Accounts will be compensated \$1.50/kWh of load reduction. Accounts that reduce load more than 75 percent of the time will be compensated at the bonus rate of \$1.00/kWh. If the account was able to reduce load, the incentive will be issued as a one-time bill credit.

The program will call 6-12 PDP Event Days between July 1 and October 31.

BILL CREDIT: If the participant has reduced electricity use to achieve load reduction during PDP Event Days, then the account will earn a onetime bill credit.

RISK-FREE PARTICIPATION: Participating in the PDP program is risk-free. If the participant was not able to reduce load throughout the season, the customer will not receive any bill adjustments or be required to pay penalties or additional charges.

NOTICING ABOUT EVENT DAYS: This year's program season will run July 1 to October 31, and 6-12 Event Days will be called during that time. CleanPowerSF will provide notice to participating customers via its website, along with email or text messages in the afternoon before an event day.
