The following Electricity Service Agreement allows any CleanPowerSF customer to receive SuperGreen 100% Renewable service for a contract term of one to ten years. By entering into this agreement, customers may be eligible for credits toward the U.S. Green Building Council's Leadership in Energy and Environmental Design (LEED) certification program. More information on LEED certification is available at www.usgbc.org/leed.

Please note: CleanPowerSF cannot guarantee that customers who enter into this agreement will be eligible for, or receive any credits toward, LEED certification. CleanPowerSF is not responsible for any changes to the LEED program requirements during the term of the service contract.

Terms and Conditions for SuperGreen Multi-Year Electricity Service Agreement

TERMS AND CONDITIONS OF SERVICE: These Terms and Conditions for SuperGreen Multi-Year Electricity Service Agreement (Agreement) establish the requirements for customer entering into a long-term electricity supply contract with CleanPowerSF. The CleanPowerSF Terms and Conditions attached hereto will also apply to customer’s service. To the extent of any conflict between the terms of this Agreement and the CleanPowerSF Terms and Conditions, the terms of this Agreement will take precedence.

LEED CREDIT ELIGIBILITY: CleanPowerSF cannot guarantee that, by entering into this Agreement, customer will be eligible for, or receive credits toward, the U.S. Green Building Council’s Leadership in Energy and Environmental Design (LEED) certification. CleanPowerSF is not responsible for any changes to the LEED program requirements during the term of the service contract.

TERM AND RENEWAL: Customer may opt for an initial term of one (1) to ten (10) years (Term). Upon the completion of the initial Term, customer will have the option of renewing this Agreement for another one (1) to ten (10) year Term. Customer must notify CleanPowerSF within thirty (30) days of the expiration of the initial Term whether customer elects to renew. If customer does not elect to renew, or otherwise notify CleanPowerSF of its choice of another service option or provider, customer will receive SuperGreen service under the CleanPowerSF Terms and Conditions attached hereto.

OPT-OUT WAIVER: During the initial Term of this Agreement, customer waives its right under California Public Utilities Code section 366.2(c)(11) to opt out of service with CleanPowerSF.

RATES: During the initial or renewed Term of this Agreement, CleanPowerSF will provide customer with CleanPowerSF’s SuperGreen 100% renewable electricity service at current rates published at cleanpowersf.org/rates. These rates are subject to change. This Agreement does not provide customer with any special rates or discounts.

QUALIFIED RESOURCES: During the initial or renewed Term of this Agreement, CleanPowerSF will provide customer with 100% renewable, Green-e Energy certified electricity, comprised of wind and solar energy resources from California that have come online since January 1, 2005. Please note that CleanPowerSF will not track Renewable Energy Credit (REC) retirement by individual customer. However, we ensure that we have acquired and retired sufficient renewable energy for 100% of SuperGreen customers' usage over the course of the year, including your company's usage if you are a SuperGreen customer. REC retirement can be verified via the Western Renewable Energy Generation Information System (WREGIS). CleanPowerSF will provide the annual WREGIS report upon customer request.

TERMINATION: If customer terminates this Agreement more than 30 days after the start of the initial Term or any renewed Term, and prior to the end of the initial Term or any renewed Term, customer will be subject to the termination fee set forth in the schedule below for the remainder of the initial or renewed Term. A termination notice must be received five business days prior to the account's meter read date in order to take effect the following month.

NEW SERVICE OPTIONS: During the initial or renewed Term of this Agreement, CleanPowerSF will notify customer of any new CleanPowerSF service options that customer may elect without being subject to the termination penalty set forth above.

FAILURE TO PAY: In addition to the terms set forth in CleanPowerSF's Terms and Conditions of Service, if the customer's service is transferred to PG&E for failure to pay customer will be subject to the supply termination fee set forth above.
